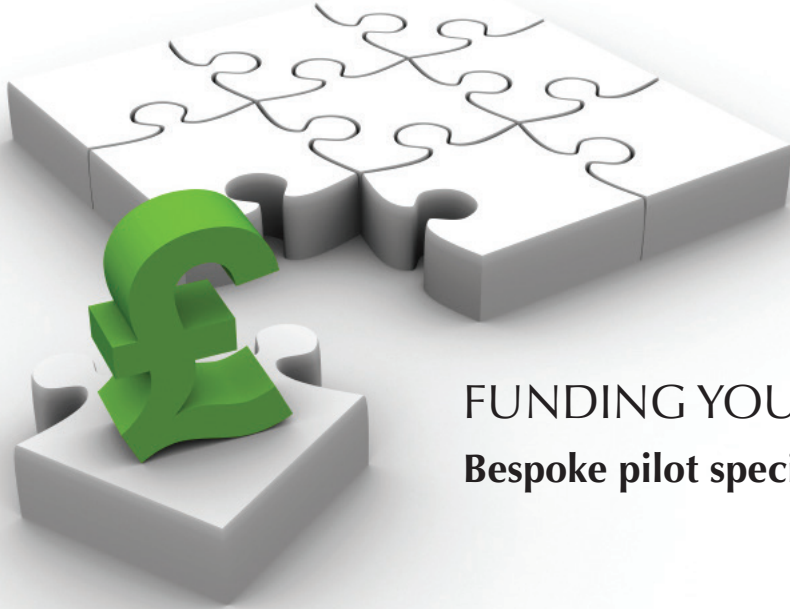

FUNDING YOUR PILOT TRAINING

Bespoke pilot specific training loans

Funding for airline pilot training has long been a major obstacle for those who wish to get into this most rewarding career. The important thing is to recognise that money spent on obtaining professional pilot licences is a real investment in yourself and your future. The demand for air travel, over the last twenty or so years, has always increases year on year by around 5-8%. The world will always need airline pilots.

2FLY are excited to offer you the chance to apply for a pilot specific training loan. Your loan can be secured or unsecured. The loans available here are only applicable to funding the 2FLY Pro-Pilot Airline Programme and are only available to candidates who not only fulfill the loan criteria but have successfully completed the **2FLY Cadet Assessment** and received a formal offer from 2FLY for a place on the programme. All applications are dealt with on a case-by-case basis.

UNSECURED

- Based on credit score, assessment score & employability matrix
- Can borrow up to 50% of the total course fees
- APR From 6%
- Loan repayment up to 10 years
- Loan holiday up to around 17 months

SECURED

- Loans secured against equity in UK property
- Property can be owned by a family member
- Can borrow up to 100% of the total course fees
- APR from approx. 4.6%
- Loan repayment up to 25 years keeping monthly payments to a minimum
- No loan holiday

HOW TO OBTAIN THE LOAN

Cadet Assessment is the key

The main purpose of the 2FLY Cadet Assessment is to minimise risk. Professional pilot training is a significant investment and commitment, so it is therefore crucial we ascertain whether you have the necessary aptitude and potential to successfully complete a programme of commercial pilot training.

Your successful completion of the Assessment will result in the following:

1. **You receive a formal offer of a place on a 2FLY Pro-Pilot Airline Programme**
2. **You have the option of applying for a bespoke pilot specific training loan - as described within this document**
3. **The unlocking of the 2FLY Financial Guarantee (see back page)**



2FLY FINANCIAL GUARANTEE

Protecting your investment

The 2FLY Financial Guarantee is available to candidates that have successfully completed the Cadet Assessment Process. Passing the assessment indicates that the likelihood of you **not** completing the 2FLY Pro-Pilot Airline Programme **through lack of aptitude** are minimal. To help you make the decision to invest in your airline pilot career 2FLY offer you this guarantee:

If 2FLY has to terminate a cadet's training due to his or her lack of aptitude, all training fees paid by the cadet to 2Fly up to that point* will be refunded†

Notes:

*2FLY operates a policy of not requiring the whole course fee 'up-front' but in staged payments

†All refunds are wholly at the discretion of 2FLY management and all claims will be dealt with on a case-by-case basis.
